This paper provides an overview of the activities of the AIECE working group on longer-term prospects and structural change in the period 1994-2007. It is the third overview of the activities.¹ Key statistics on the activities are provided in the first section of the paper. This is followed by a classification of the presentations held (section 2) and remarks on the evolution of topics over time (section 3). The complete list of presentations is given in the Annex.

1 Key statistics on the activities of the working group

In the review period 1994-2007, the working group had 28 meetings (twice a year) with 77 presentations.² The spring meetings were held outside Brussels in the afternoon after the General Meeting, while the autumn meeting were held in Brussels during the afternoon before the General Meeting of the AIECE. The number of participants varied widely, from 15 to 55.³ Almost all meetings were chaired by Joachim Volz (DIW, Berlin). He was chairman of the working group from autumn 1993 up to spring 2006. He was succeeded by Cathérine Mathieu (OFCE, Paris).

2 Topics discussed

To get an overview of the topics discussed, the 77 presentations have been classified (see Table above). Some presentations covered several issues and are therefore classified under several

topics. The topics chosen for the classification have some overlap. This is for instance the case for the topic social security and welfare state and the topic ageing and pensions.

As can be expected for this working group, most presentations are on medium-term issues (16). This number includes presentations on the medium-term outlook. There are also many presentations on labour markets and wages (13), enlargement of the EU (10) and social security and welfare state (10).

There are not many presentations on environment (1), emerging economies (1) and financial markets (2).

3 Topics discussed over time

Recently, there have been more presentations on social security and welfare state, while there were fewer presentations on modelling. Not surprisingly, most presentations on enlargement and transition economies were in the years 2002-2004.

Questionnaires on medium-term forecasts played a more important role in the past than in recent years.
