Aims :	The dissertation must demonstrate the author's ability to describe correctly the results of a personal, objective and methodical work. The length of the dissertation is not a criteria in evaluating its quality. Similar to the other forms of learning, the dissertation is an essential component of the programme to which it belongs. It consists of research work which students should consider as a first step in research in their particular field. The dissertation is a research work : - specific, as regards the other teaching activities ; - methodical, the underlying methodology has already been acquired in the bachelor and masters programme ; - ntegrated in the programme and limited to the scope of the subject. Evaluation methods :	The evaluation of the dissertation is based on :         - the achievement of the objectives         - the ability to present a relevant and well documented summary         - significant personal input by the student as well as the ability to justify the methodological choices         - the coherence and completeness of the work         - the quality and relevance of the written and illustrated work.         3 credits must be validated in the Master first year by submitting to the supervisor a draft of the dissertation as well as a bibliography.
Teaching methods :	/
Content :	<ul> <li>The masters dissertation, irrespective of the subject, allows a student to :</li> <li>- carry out a critical analysis and summarise a given scientific topic,</li> <li>- put a specific issue/statement in context drawing on existing information,</li> <li>- present the results of the dissertation by justifying the methodological choices, explaining the hypotheses and scientifically stating the results obtained.</li> <li>A dissertation must contain at least 80 pages (200.000 caracters long), a length deemed necessary to make a detailed presentation of a research hypothesis, a proof or of a well-argued account supported by quotations, references, sources and demonstrating familiarity with the subject bibliography. The dissertation includes an introduction relating in particular to methodology, a development displaying the analysis and synthesis of the argument, a conclusion and a bibliography.</li> </ul>

Other infos :	In case a student registers for two masters with two different focuses in the same academic year, the second dissertation will be assessed against the following criteria: The second dissertation topic may be different than the first dissertation. The expectations will be identitical except for the length: the second dissertation may be only 100 000 caracters long (excluding bibliography and annexes). The second dissertation topic may be the same as the first dissertation, and may constitute the development of a second fold, which could not be studied in the first dissertation. The extension of the topic may be done either by extending the corpus, or by studying new issues on the same corpus. It should be at least 100 000 caracters long of which a maximum of 30 000 caracters could be devoted to sum up the first dissertation. Part of the first dissertation bibliography may also be included. The dissertation will be assessed by two academic readers The correctness of language will taken into account in the final grade.
