Evaluation methods :	Evaluation: Students will be evaluated for the theoretic part by a written exam comprising a practical problem and on their personal/ group work. An exam will also be organised for the microscopic and macroscopic parts, while a continuous evaluation is organised for the phytochemical part.
Content :	A/ Phytochemistry: <ul style="list-style-type: none"> <li>- Quality control of plant and plant extracts, particular analytical methods and resolution of problems (case studies)</li> <li>- Biosynthesis, physico-chemical and pharmacological properties of the main natural active compounds</li> </ul> B/ Medicinal plants: <ul style="list-style-type: none"> <li>- Generalities on uses, advantages and drawbacks of phytotherapy, differences with homeopathy, risks of plant uses</li> <li>- Main forms of plants or extracts used in pharmacy</li> <li>- Examples of the most frequently used plants in phytotherapy (part used, chemical composition, quality criteria, side effects, contra-indications and doses)</li> <li>- Bibliographical research in small groups on one plant and critical analysis of a paper on this plant (case study)</li> </ul> C/ Practical part: <ul style="list-style-type: none"> <li>- Macroscopic identifications of medicinal plants in thees</li> <li>- Microscopic identification of examples of medicinal plants</li> <li>- Chemical analysis of a drug according to the European Pharmacopea</li> </ul>
