Aims :	<p>The students will obtain knowledge about the basic concepts of nonparametric statistical inference. They will learn about elementary nonparametric testing procedures. They will be able to use these nonparametric procedures for analyzing real data, and this by using, for example, statistical software packages.</p> <p><i>The contribution of this Teaching Unit to the development and command of the skills and learning outcomes of the programme(s) can be accessed at the end of this sheet, in the section entitled "Programmes/courses offering this Teaching Unit".</i></p>
Content :	<p>Content - Hypothesis tests concerning location and dispersion of a population, given an i.i.d. sample - Detection of differences in location and/or dispersion between two populations - Goodness-of-fit tests for checking whether an unknown distribution belongs to a given parametric family of distributions, or equals a specific parametric distribution - Measures of association between two (or more) random variables - The use of order statistics and rank statistics in nonparametric estimation and testing procedures</p> <p>Teaching methods During the lectures we will explain for each of the statistical procedures the following : the motivation behind a test statistic, how to obtain the distribution of the test statistic under the null hypothesis, and how to construct the testing procedure. The aim is to get insight into nonparametric testing procedures and to learn about the different aspects of such procedures. At the end of the course the students have to work through some course work (a project) that will allow them to get more familiar with the use of nonparametric methods in practical applications, when for example analyzing real data.</p>
