Main themes :	<p>FR THEME 2</p> <p>The course is divided into three parts:</p> <ul style="list-style-type: none"> <li>&amp; uill; the first part is devoted to the study of the basic mechanisms of general accounting;</li> <li>&amp; uill; the second part focuses on a more in-depth analysis of some specific accounts of P.C.M.N. addressing the valuation rules relating to them;&amp; bsp;</li> <li>&amp; uill; the third part consists of examining the financial structure of the company (analysis of its funding sources, its uses of funds and the balance of his assets using financial ratios such as working capital) to analyze its origin of the profit (calculation of management ratios) and finally to explain its financial performance (relationship between equity and income statement: profit rate, overall profitability, financial profitability, leverage, etc.)</li> </ul> <p>&amp; bsp;</p>
