Analysis of the programmes and their objectives in relation to secondary school and academies education programmes and in concert with the specific objectives of each section/option. Introduction to the specificities of intellectual synthesis and overview of the specific means and methods available for the transmission of information in the domains of art history, archaeology and musicology. Theoretical presentations and experiments on: - communication conditions; - the construction of a presentation; - the constitutive parts of oral communication; - oral communication skills.
