Main themes	The articulation between theology and law; the theologies of canon law; the notion of the fundamental rights of the faithful; the role and effectiveness of canon law in the life and practice of the Church.

Evaluation methods	Classical oral examination. A list of questions will be available to students at the end of May. The examination consists of a theoretical question and a practical case.
Content	<p>After a historical and conceptual introduction, the course presents the major places of contemporary canon law: what are the issues and concrete practices in general, based on the structure of the 1983 Code, and in particular on the notion of fundamental rights of the faithful.
