Main themes	<ul> <li>This course overviews topics in computational finance and financial econometrics (data sciences applied to finance).</li> <li>The emphasis of the course will be on making the transition from an economic model of asset return behavior to an econometric model using real data.</li> <li>This involves: <ol> <li>exploratory data analysis;</li> <li>specification of models to explain the data;</li> <li>estimation and evaluation of models;</li> <li>testing the economic implications of the model;</li> <li>forecasting from the model.</li> </ol> </li> <li>The modeling process requires the use of economic theory, matrix algebra, optimization techniques, probability models, statistical analysis/econometrics, and statistical software (R).</li> <li>Both edX and DataCamp plateforms will be used to allow practical training and continuous learning on R.</li> </ul>
