Main themes	<p>An introduction to historic and comparative linguistics, as applied to Indo-European. This course deals with the following themes:</p> <ol style="list-style-type: none"> 1. The history of the comparative study of the Indo-European languages; 2. The principals and methods of genetic comparison; 3. The phonological system of proto-Indo-European; 4. Accenting and vocalic alternation; 5. Word structure (root, suffix, ending); 6. Nominal and verbal morphology.
