Aims	<p>The dissertation must demonstrate the author's ability to describe correctly the results of a personal, objective and methodical work. Similar to the other forms of learning, the dissertation is an essential component of the programme to which it belongs. Teaching methods	<b>Due to the COVID-19 crisis, the information in this section is particularly likely to change.</b> The student must meet his or her supervisor on at least two occasions in the first year. On the first day of the final session in his or her first year at the latest, he or she will send the supervisor a file summarising the work carried out over the course of the year.
