Content	2018-2019 A <i>Tridentine Paradigm</i> ? Invention and reinvention of Tridentine Catholicism (18th - 20th centuries). The seminar shall explore the historiography of Trent and Tridentine catholicism and will discuss Paolo Prodi's stance according to which the Early modern era and the 19th and 20th centuries can be described as an "era" in the history of the Church. It will focus on the writing of the history of the Council of Trent and of Catholic Reformation and its relationship to the religious issues of each time. The seminar will specifically emphasize the centrality of the 19th and 20th centuries in the elaboration of the historical image of Early modern catholicism and will try to explore how historical imagination shaped modern Catholicism, including different understandings of Catholicism.
