Content	Building on teaching units LTRAD2700 and LTRAD2710, this teaching unit focuses on the study and translation of the German Kurzgeschichte literary genre: its start in Germany, its main characteristics (short text, short span of action, no introduction, time and place, characters, everyday nature of the action, defining moment, open ending), and its evolution in the German-speaking world To illustrate this, students will be asked to translate a previously translated and published short story or a yet-to-be-translated short story and will have to compare and argue their translational choices. Using machine translation software during a translation exercise or exam is forbidden.
