Main themes	The course presents an introduction to the foreign policy of the EU, which is broadly defined as the the area of European policies that is directed at the external environment with the objective of influencing that environment and the behaviour of other actors within it, in order to pursue interests, values and goals. It discusses the nature, history, institutional framework and policy-making dynamics of EU foreign policy, followed by an analysis of its four main facets (CFSP, CSDP, external action and the external dimension of internal policies).
