Main themes	- General introduction to management and its scientific sources - Global management tools (strategy tools, planning, risk management...) - the choice of the organisational structures - accountant and budgetary control in the public sector (general concepts) - Management control and performance contracts

Teaching methods	<p>Due to the COVID-19 crisis, the information in this section is particularly likely to change.</p> <p>Introduction on theories and concepts by the teacher, presentation and discussion of cases with the students, invitation of experts</p>
Content	<p>The course is divided into six parts preceded by a short introduction on the scientific principles of management. I. Strategic management of public organizations using global management tools. II. The choice of the organisational structures III. General introduction to budgeting and public accounting IV. Management control: administrative controls and management controls, management indicators and dashboards, total quality management. V. Audit and risk management. VI. Change management.</p> <p>Each part starts with an initiation to management methods and tools, followed by a critical analysis on the use of these methods and tools within the framework of public organizations.</p>
