Content	Theories and practices of democracy and the role of religions (2019-2020, Q1) Democracy is still recognized as the best form of government in the Western world and in other regions of the planet. But it is undergoing a profound crisis. The course reconstructs some major lines of debate in political theory and presents a variety of models of democratic deliberation. The current situation is characterized by the rise of right-wing and left-wing populisms and by the difficulty of organising majorities after the decline of political parties which traditionally had their place at the heart of the mechanics of power. The course particularly focusses on expressions of political ethics that have been developed in different religious traditions. The concept of "public theology" will be introduced and tested within selected contexts.
