Main themes	The study of the Bible - c.q. the Old Testament - from the perspective of - its textual witnesses (Hebrew and ancient <i>versiones</i>) - the history of transmission and its implications for theology - the relationship between textual criticism and redaction criticism
Aims	1 - present the most important textual witnesses of the Bible, c.q. the Old Testament ---- 2 - analyse a biblical - c.q. Content	Until the development of book printing, there were no two identical copies of the Bible, i.c. the Old Testament. For centuries, variants in extant biblical manuscripts have been considered as contaminations of an original and reliable text; they were mainly evaluated as deliberate or erroneous changes by a copyist/translator. Until the discovery of the Dead Sea Scrolls in 1947, the discipline of textual criticism aimed indeed at investigating these processes of modification during the textual transmission, in order to restore the 'original' text. From 1947 on, however, a radical revolution has been initiated with respect to the understanding of the compositional history of the Old Testament text: given the radical plurality and pluriformity of the extant texts, the idea of a single 'original' text of the Bible seems to be nothing else but an illusion. The first part of the course – that mainly focuses on Old Testament textual criticism – will present the most important textual witnesses: the Masoretic text, the Septuagint, the Samaritan Pentateuch and the scrolls from the Judean desert. In the second part, the discipline of Textual criticism as such will be dealt with: what are its methods, and what is its impact on the reading and interpretation of the Bible? This will clearly demonstrate that a meticulous text-critical analysis is incompatible with a fundamentalist reading of the Bible.
