Place of the course	Louvain-la-Neuve
Main themes	This part of the course aims to examine the role that social, economic, political and cultural factors play in the geopolitics of natural resources and development and is organized in two sections. Drawing on concepts from Political Ecology, Ecological Economics and Development Studies, the first section provides the foundations to understand the main topics that explain the geopolitics of natural resources and its implications for sustainable development. The interplay of these topics is illustrated by a review of socio-environmental conflicts observed in and development strategies pursued by low and medium-income countries. The second section analyses the developmental possibilities, risks and threats arising out of the current distribution and management of natural resources, notably land and water, in relation to food security and sustainable agriculture. This section discusses the policy and institutional options that countries from the Global South can pursue in order to influence the global governance of natural resources.
