Evaluation methods	<p>The evaluation will consist of two parts:</p> <p>A. Open book written exam</p> <p>B. Individual reflection paper (to be submitted before the exam)</p> <p>In the final grade, part A is worth 17/20 and part B is worth 3/20.</p> <p>The conditions of the evaluation are specified by the teacher at the first class. The evaluation methods are identical in the first and second exam session.</p>
Teaching methods	<p>The course sessions alternate between lectures and interactive moments (exercises, discussions, case studies) organized in such a way that the students mobilize and appropriate the concepts presented in the course. Theoretical presentations alternate with practical exercises throughout the course.</p>
Content	<p>This teaching unit consists of a series of theoretical presentations introducing students to evolutions with regard to the modes of regulation and evaluation practices of educational organizations, as well as to the main concepts that allow for an analytical look at these issues.</p>
Inline resources	<p>Moodle provides bibliographic references and other documents that support the course, as well as up-to-date practical information about the course.</p> <p>Students can also use Moodle to ask questions or make comments of collective interest.</p> <p>Regular monitoring of the Moodle site is essential. It will contain all the necessary instructions regarding participation in the sessions, teaching methods and evaluation methods.</p>
