Evaluation methods	<p>During the term: formative assessment. January and August/September sessions: written examination.</p> <p>Students are required to take one written examination per translation workshop (i.e. economic and legal) in connection with the topics dealt with during the term.</p> <p>The overall mark will be calculated by averaging the two marks. In case of an overall fail mark, the failed parts will have to be retaken during the August/September exam session. In case of an unjustified absence, students will have to retake the two translation workshops chosen during the August/September exam session.</p>
Teaching methods	Personal tutorial work, face-to-face
Content	<p>- economic translation workshop ' Turkish/French (VANRIE Pierre): translation of texts addressing various theoretical approaches to economics, focusing on related vocabulary as well as on names and acronyms of international institutions.</p> <p>The texts to be translated will give a general description of specific economic situations, leading to discussions on the economic situation of a given country, including but not limited to Turkey.</p> <p>Without going into complex technical considerations requiring a high level of economic expertise, the course will set out to tackle various aspects of economic analysis (social, political or technological dimensions)</p> <p>- legal translation workshop ' Turkish/French (VANRIE Pierre): translation of legal texts professional translators are most confronted with, such as contracts (CDD and CDI work contracts, rental contracts, etc.); family composition; calls for tenders; non-profit status.</p>
