| Content                     | The Specialised Translation Seminar in International and European Affairs is devoted to the translation (from Spanish into French) of texts focusing on EU topics written by experts. In the introductory section of the course, the main tools for the translation of EU documents (such as EUR-Lex, IATE or the Interinstitutional Style Guide) will be presented so that the students can use them in the translation exercises. Where appropriate, texts will be translated with the aid of computer-assisted translation (CAT) tools (SDL Studio©, MultiTrans© and/or Sketch Engine©). The exercises will be supervised by the teacher and will receive both group and individual correction.  Using machine translation software during a translation exercise or exam is forbidden. Such software may only be used as a starting point for a post-edition exercise given by the teacher. |
