## OBST2MC - Teaching profile

### Learning outcomes

---

This complementary master's programme aims to prepare doctors to become officially recognised holders of the specific professional title of Specialist Doctor in Obstetric-Gynecology (Ministerial Decree of 15.09.1979, published on 26.09.1979).

### Programme structure

---

The training course includes full time apprenticeships in recognised services and teaching centres. It lasts for at least five years, full-time, including at least two years of foundation studies and three years of higher studies. The apprenticeship project established by the university promotor must be approved by the ministerial validation committee for the speciality. These periods of practical training include being on call.

## OBST2MC Detailed programme

### Programme by subject

---

Parallel to the practical training, the candidate specialist will follow a university course organised as follows :

#### **part - Foundation studies (FUS)**

Two years of studies consisting of :

- Theoretical courses : complements of endocrinology in obstetrics and in gynecology, pregnancies at risk and foetal medicine, diagnostic and therapeutic approaches in sterility and oncology, obstetrical echographies, andrology, pathology of the external genital organs, gynecology in adolescents, sexology, basic notions of surgery and general and loc-regional anaesthetics, gynecological oncology.
- Seminars: Seminar on obstetric gynecology
- A period of supervised hospital work : obstetrical demonstrations, gynecological and andrological demonstrations

In addition:

inter-university conferences (obstetrics - antenatal diagnoses - oncology - senology - gynecological surgery)

#### **part - Higher studies**

Three years of studies consisting of :

- Theoretical courses : obstetrical echographies, andrology, pathology of external genital organes, gynecology in adolescents, sexology and gynecological oncology
- Seminars: Seminar on obstetric gynecology
- A period of supervised hospital work : obstetrical demonstrations, gynecological and andrological demonstrations

In the second year, the specialist candidate will have the possibility of enrolling for a university certificate (CE) in oncological gynecology.

During the course of these three years, the candidate specialist will accomplish a period of practical work experience from 6 to 12 months in a surgical service essentially dedicated to abdominal surgery. Besides this, he may accomplish an apprenticeship in one of the specialities mentioned by the Ministerial Decree, with the approval of the selection committee and the ministerial validation committee.

## OBST2MC - Information

### Admission

---

*In the event of the divergence between the different linguistic versions of the present conditions, the French version shall prevail*

Decree of March 31st 2004 defining higher education, favoring its integration in the European framework of higher education and refinancing universities.

The admission requirements have to be met at the time of enrolment at the university.

The mentioned information may of modification for 2014-2015

All information can be obtained from the [University's Enrolment Office \(Service des inscriptions – SIC\)](#).

The following students, after meeting the conditions set by the academic authorities, have access to the complementary Master's degree with the aim of obtaining the grade that these studies sanction:

- An academic Master's degree within the same field allowing 2nd-cycle studies, including at least 120 credits
- An academic Master's degree, following a decision by the academic authorities, under the complementary conditions that they set and as a result of a motivated decision by the jury
- An academic grade which is similar to those mentioned above, issued by the Flemish Community, the German Community or the Royal Military Academy, under the same conditions
- A foreign academic grade that has been acknowledged as being equivalent to those mentioned above, in application of this decree, a European-level directive or an international convention, under the same conditions
- Under the same conditions, one or several titles or academic grade issued by the Flemish Community, the German Community or the Royal Military Academy, sanctioning 2nd-cycle studies and valued at least 300 credits by the jury, or sanctioning 2nd-cycle studies and valued at least 240 credits completed of 60 credits, the all that must be valued by the jury according to the decree of March 31st, 2004 (art 54, 5 °)

### Specific Admission Requirements

#### Admission conditions

- The applicant must hold the degree title of Doctor in Medecine or be a Doctor from a member country of the European Union authorising medical practice in Belgium.
- The applicant must be in possession of a document attesting that, at the end of the selection exams, he was retained as a specialist candidate in Obstetric-gynecology, in a Belgian medical faculty.

The juridical context and practical procedures regarding these selection tests can be obtained from the secretary's office. Degree holders from outside the European Union are only allowed to register on the programme in the context of procuring a university certificate for partially specialised training for the duration of two years (if they are in the process of doing a specialisation in their country of origin) or for an in-depth specialised training course for the duration of one year (if they are already recognised as specialists in their own country).

The Royal Decree of 30.05.2002, relating to the planning of the medical offer, published on 14.06.2002, applies to those candidates wishing to obtain the title of specialist doctor in Obstetric-Gynecology (those candidates are thus counted among the general practitioner candidates or specialists in the context of the numerus clausus).

#### Admission procedures

Applications for admission must be addressed to the academic supervisor. The organisation of the entrance selection tests is arranged in accordance with the calendar and the general examination rules and regulations.

## Evaluation

---

The evaluation methods comply with the [regulations concerning studies and exams](#). More detailed explanation of the modalities specific to each learning unit are available on their description sheets under the heading "Learning outcomes evaluation method".

An evaluation of the the knowledge acquired is carried out at the end of each part of the programme. In addition, the candidate will write a thesis and/or an article and have it published in a specialised journal. Further to the application of the Royal Decree of 16 March, 1999, at the end of the first two years of training, the candidate will receive an attestation proving that he has successfully accomplished a specific university training course.

Upon fulfilment of the above-described training requirements, the teaching committee will award the academic title in Obstetric-Gynecology Medicine.

This title does not replace official recognition by the ministerial validation committee. It attests to the successful completion
