Introduction

INGE1BA - Teaching profile

Learning outcomes

This programme aims at developing the students' capacity for reflection, critical analysis and decision-making in the domains of Economic and Business Sciences, of Sciences and of Technology.

It is based, on the one hand, on the acquisition of knowledge within the disciplines of Economic Science, Business Engineering Sciences and Social Sciences, the Exact Sciences and Technology, and, on the other hand, on the know-how acquired through a pedagogical approach which fosters the active participation of the students in their own training. This approach is rooted in the reality of economic life and organisations.

On a general level, one year is dedicated to the acquisition of knowledge in the general disciplines belonging of the ESPO Faculty and the Exact Sciences, one year is dedicated to the specific developments of those disciplines with respect to Economic Analysis and Business Science, and one year is dedicated to the study of economic and business problems and methods as well as to the study of technologies. In comparison with the bachelor's programme of Economic and Business Sciences, this programme is much more clearly orientated towards the study and application of the quantitative methods of Business Engineering.

On successful completion of this programme, each student is able to :

AAC2.3. Identifier et sélectionner les publications et les méthodes appropriées (en questionner la validité et la pertinence) pour analyser une question relative à la (aux) discipline(s) de son orientation.

AAC2.4. Développer une analyse critique et réflexive de l'information et des publications (en français et en anglais), auxquelles l'étudiant sera confronté dans sa vie universitaire, et en réaliser une synthèse pertinente, conforme aux règles de base de la communication scientifique, en regard de la question qui est étudiée.

Pour 2 langues étrangères* (anglais et néerlandais ou allemand ou espagnol) : communiquer à l'oral et à l'écrit de façon claire, cohérente, argumentée et avec aisance sur des sujets d'ordre général ou relatifs au domaine d'études ; Percevoir les différences et similitudes entre la culture cible (relative à la langue concernée) et la culture d'origine ainsi qu'utiliser des stratégies appropriées pour établir le contact avec des locuteurs de la culture cible.

AAC4.3. Travailler en équipe : interagir, collaborer et s'organiser efficacement au sein d'une équipe et gérer les relations de groupe.

AAC4.4. Adopter une attitude de dialogue efficace et respectueuse en ajustant le mode de communication en fonction de l'interlocuteur (pairs, enseignants, personnel administratif, monde socio-professionnel) et en faisant preuve de capacité d'écoute, d'empathie et d'assertivité.

AAC5. Agir en autonomie, en acteur critique et responsable soucieux du respect de valeurs éthiques et citoyennes et en ayant construit son projet de formation en perspective de la poursuite de son développement personnel et professionnel.

AAC5.1. AAS1.3. Maîtriser un socle de savoirs dans le domaine des mathématiques, des méthodes quantitatives en économie et gestion, ainsi qu'en informatique / algorithmique.

AAS1.4. Maîtriser un socle de savoirs dans le domaine du droit, et plus spécifiquement les règles législatives qui régissent toute activité économique.

AAS1.5. Maîtriser un socle de savoirs dans le domaine des sciences et technologies (chimie, physique et applications technologiques).

AAS5.3. Appréhender de manière critique les enjeux du 21^e siècle, notamment les interrelations entre crises écologiques, sociales et économiques.

Programme structure

The programme is organised in the form of one single line of studies of 180 credits, into which are integrated 26 credits in Sciences and Technology.

The programme comprises courses in Sciences and Technology, and an intensive course in Mathematics and Statistics. Nevertheless, the programme is still conceived in such a way as to satisfy the minimum demands of each of the subjects within the pool of subjects common to the ESPO. This thus allows for the same possibilities of re-orientation as the other ESPO bachelor programmes, thanks to the recognition of the equivalence of the credits.

In addition, those students admitted - after the selection process - to the "Creating a Company" orientation, must add one extra course to their programme for (a maximum of) 9 credits. This "Creating a Company" orientation is spread over the third year of the Bachelor's and over the two years of the master's of Business Engineering.

Course prerequisites

The **table** below lists the activities (course units, or CUs) for which there are one or more prerequisites within the programme, i.e. the programme CU for which the learning outcomes must be certified and the corresponding credits awarded by the jury before registering for that CU.

These activities are also identified in the **detailed programme**: their title is followed by a yellow square.

Prerequisites and student's annual programme

As the prerequisite is for CU registration purposes only, there are no prerequisites within a programme year. Prerequisites are defined between CUs of different years and therefore influence the order in which the student will be able to register for the programme's CUs.

In addition, when the jury validates a student's individual programme at the beginning of the year, it ensures its coherence, meaning that it may:

- transform a prerequisite into a corequisite within the same year (to enable the student to continue his or her studies with a sufficient annual course load)
- require the student to combine registration in two separate CUs which it considers necessary from a pedagogical point of view.

Access Requirements

Decree of 7 November 2013 defining the landscape of higher education and the academic organization of studies.

The admission requirements must be met prior to enrolment in the University.

In the event of the divergence between the different linguistic versions of the present conditions, the French version shall prevail.

General access requirements

Except as otherwise provided by other specific legal provisions, admission to undergraduate courses leading to the award of a Bachelor's degree will be granted to students with one of the following qualifications :

1. A Certificate of Upper Secondary Education issued during or after the 1993-1994 academic year by an establishment offering full-time secondary education or an adult education centre in the French Community of Belgium and, as the case may be, approved if it was issued by an educational institution before 1 January 2008 or affixed with the seal of the French Community if it was issued after this date, or an equivalent certificate awarded by the Examination Board of the French Community during or after 1994;
2. A Certificate of Upper Secondary Education issued no later than the end of the 1992-1993 academic year, along with official documentation attesting to the student's ability to pursue higher education for students applying for a full-length undergraduate degree programme;
3. A diploma awarded by a higher education institution within the French Community that confers an academic degree issued under the above-mentioned Decree, or a diploma awarded by a university or institution dispensing full-time higher education in accordance with earlier legislation;
4. A higher education certificate or diploma awarded by an adult education centre;
5. A pass certificate for one of the [entrance examinations](https://uclouvain.be/fr/etudier/inscriptions/examens-admission.html) (https://uclouvain.be/fr/etudier/inscriptions/examens-admission.html) organized by higher education institutions or by an examination board of the French Community; this document gives admission to studies in the sectors, fields or programmes indicated therein;
6. A diploma, certificate of studies or other qualification similar to those mentioned above, issued by the Flemish Community of Belgium, the German Community of Belgium or the Royal Military Academy;
7. A diploma, certificate of studies or other qualification obtained abroad and deemed equivalent to the first four mentioned above by virtue of a law, decree, European directive or international convention;

Note:

Requests for equivalence must be submitted to the Equivalence department ([Service des équivalences](#)) of the Ministry of Higher Education and Scientific Research of the French Community of Belgium in compliance with the official deadline.

The following two qualifications are automatically deemed equivalent to the Certificate of Upper Secondary Education (Certificat d'enseignement secondaire supérieur – CESS):

- European Baccalaureate issued by the Board of Governors of a European School,
- International Baccalaureate issued by the International Baccalaureate Office in Geneva.

8. Official documentation attesting to a student's ability to pursue higher education (diplôme d'aptitude à accéder à l'enseignement supérieur - DAES), issued by the Examination Board of the French Community.

Specific access requirements

- To be eligible to apply to a bachelor's programme, holder of a non-belgian degree who do not have Belgian student status must also:
 - have earned a secondary school degree within the last three years;
 - not already hold a bachelor's degree; and,
- Candidates, whatever their nationality, with a secondary school diploma from a country outside the European Union, must have obtained an average of 13/20 minimum or, failing that, have obtained this average, have passed one year of study in Belgium (for example special Maths / sciences).
- For any secondary school diploma **from a European Union country**, the admission request must contain the equivalence of your diploma or, at the very least, proof of the filing of the equivalence request with the Wallonia-Brussels Federation (French Community of Belgium). For any information relating to obtaining an equivalence, please refer to [the following site](#).

- Not to have obtained a secondary education diploma for more than 3 years maximum. Example: for an admission application for the academic year 2021-2022, you must have obtained your diploma during the academic years 2018-2019, 2019-2020 or 2020-2021. In the French Community of Belgium, the academic year runs from September 14 to September 13.[1_information/2021/common-bachelor/](#)

Access based on validation of professional experience

Admission to undergraduate studies on the basis of accreditation of knowledge and skills obtained through professional or personal experience (Accreditation of Prior Experience)

Subject to the general requirements laid down by the authorities of the higher education institution, with the aim of admission to the undergraduate programme, the examination boards accredit the knowledge and skills that students have obtained through their professional or personal experience.

This experience must correspond to at least five years of documented activity, with years spent in higher education being partially taken into account: 60 credits are deemed equivalent to one year of experience, with a maximum of two years being counted. At the end of an assessment procedure organized by the authorities of the higher education institution, the Examination Board will decide whether a student has sufficient skills and knowledge to successfully pursue undergraduate studies.

After this assessment, the Examination Board will determine the additional courses and possible exemptions constituting the supplementary requirements for the student's admission.

To be able to access the master's of Business Engineering, the student needs to have completed an "initiation to labour employment", and to have drafted an analytical report on the subject. This initiation comprises one week of mainly manual work experience in an entrepreneurial or associative environment (outside of the programme).

Other studies available upon completion of the programme

The bachelor's degree in Business Engineering entitles access to the master's organised by the other departments of the Faculty of Economics, Social and Political Sciences or by other Faculties, subject to respect of the conditions and prerequisites specified by the bodies responsible for organising the programme in question. In the case of lacking credits, these may be made up either by being added to the master's programme (if the number of lacking credits does not surpass 15), or by the completion of a complementary/preparatory programme before embarking on the master's.
