ORTD2MC - Teaching profile

Learning outcomes

The objective of this Advanced 2nd cycle programme is to prepare dentists to gain professional status as specialist dentists in orthodontics. (Ministerial Orders of 28 May 2001 and 11 June 2001 published 5 July 2001.

Programme structure

The full-time training lasts four years and comprises a theoretical part (at least 180 hours per year), a pre-clinical part (at least 30 hours per year) and a clinical part (at least 1,290 hours per year). In addition to the internal placement in the training centre under the direction of an approved placement supervisor-coordinator, the clinical training also includes an external independent professional practice placement of at least 500 hours in an approved location and under the direction of an approved placement supervisor. During the placements, candidates devote themselves entirely to practising a specialization, according to a plan approved by the ministerial committee. During training, candidates may not undertake any clinical activity outside their placement work.

Candidates must become involved in research work in an area of the specialization. Before the end of the training, they must present a paper to a scientific meeting as well as a dissertation or an article for publication in a leading international journal.

General access requirements

Art. 112. § 1. In accordance with the general requirements established by the academic authorities, students who have:

1. a master's degree;

2. an academic degree similar to the one mentioned in the preceding paragraph awarded by a higher education institution in the Flemish Community or the German-speaking Community, or by the Royal Military Academy, by virtue of a decision of the academic authorities and in accordance with any additional requirements they may establish;

3. a foreign academic degree recognised as equivalent to those mentioned in paragraphs 1 and 2 pursuant to this decree, a European directive, an international convention or other legislation, in accordance with the same requirements.

The additional admission requirements referred to in paragraph 2 are intended to ensure that the student has acquired the knowledge and skills required for the studies in question. When the additional admission requirements consist of one or more additional course units, these may not represent more than 60 additional credits for the student, taking into account all the credits that he or she may otherwise use for admission. These course units are part of the student's study programme.

§ 2. In accordance with the general requirements established by the academic authorities, a student who holds a title, diploma, degree or certificate of higher education, in the French Community or outside it, which does not grant him or her eligibility for admission to a specialised master's course by virtue of the preceding paragraph, may nevertheless be admitted by the jury of the course in question, in accordance with the additional requirements that it establishes, if the totality of the higher education that he or she has completed or the expertise that he or she has acquired is valued by the jury to be at least 240 credits.

§ 3. By way of derogation from these general requirements, the academic authorities may also admit to a specialised master's course holders of a title, diploma, degree or certificate awarded outside the French Community which, in that system of origin, grants direct eligibility for postgraduate studies, even if the studies sanctioned by these credentials are not organised into distinct degree courses or within a time period of at least five years.

Specific professional rules

These studies lead to a professional title subject to specific rules or restrictions on professional accreditation or establishment.

Evaluation

The evaluation methods comply with the <u>regulations concerning studies and exams</u> (https://uclouvain.be/fr/decouvrir/ rgee.html). More detailed explanation of the modalities specific to each learning unit are available on their description sheets under the heading "Learning outcomes evaluation method".

There is an assessment of candidates' theoretical and practical knowledge at the end of each year which enables the programme committee to validate the academic year. At the end of the course, assessment is based on a test of candidates' theoretical and practical knowledge, on the report of the placement supervisors, on the presentation of twenty cases which have been treated and fully documents, on the presentation of a case at a public session as well as the defence of an original dissertation or article for publication in a leading international journal.

When the above requirements have been fulfilled, the programme committee will award the academic qualification of Advanced Master in Orthodontics.

This is not a substitute for recognition by the ministerial committee. It is evidence of academic and scientific training in the context of specialized training leading to the award of professional status.

To have their training period validated by the ministerial committee for orthodontics, candidates must submit their training record book, duly completed, at the end of each year of training.
