#### Introduction

The law faculties at UCLouvain (Saint-Louis - Bruxelles and Louvain-la-Neuve) and Université de Namur offer a joint advanced master's degree in human rights.

In addition to its primarily legal scope, this advanced master's degree was also developed in an interdisciplinary perspective. It aims to provide students with specialised knowledge in the field of human rights, at both domestic and international level. In its legal aspects, this advanced master's degree deals with the human rights provisions guaranteed not only by international jurisdictions and institutions but also by state laws.

In its interdisciplinary aspects, this master's degree aims to provide students with knowledge from other fields of the humanities (history, philosophy, sociology) in order to better understand and implement this protection of human rights.

Classes are taught in French, which is also the language of most course materials. A strong command of this language is therefore required. Passive knowledge of English is also necessary in order to be able to read certain related documents.

#### Programme governance and administration

The advisory council of the advanced master's degree is composed of all those involved in teaching the programme. The board is made up of professors Olivier De Schutter (UCLouvain Saint-Louis - Bruxelles), Cécile de Terwangne (UNamur) and Jogchum Vrielink (UCLouvain Saint-Louis - Bruxelles) (chairman of the advanced master's degree), and acts as an admissions committee.

The programme's administration is handled by Martin Laes (UCLouvain Saint-Louis - Bruxelles).

#### Your profile

The programme is aimed at anyone who wishes to receive specialised instruction in the field of human rights, as well as legal practitioners, lawyers, magistrates, members of non-governmental organisations and national and international civil servants. The link between theory and practice in the defence of human rights – which inspired the programme's implementation and organisation – is evident in the make-up of the target audience.

#### Your programme

Schedules are designed to allow people with active professional lives to participate. To this end, courses are held several evenings a week (5.30 - 8.30 pm) as well as a few Saturday mornings at the Saint-Louis Bruxelles campus.

## DRHB2MC - Teaching profile

### Learning outcomes

Classes are taught in French, which is also the language of most course materials. A strong command of this language is therefore required. Passive knowledge of English is also necessary in order to be able to read certain related documents.

By the end of their advanced master's degree in human rights, students will have acquired:

- Specialised and up-to-date expertise in human rights law at international, regional (European and non-European legal systems) and national level;
- Knowledge of the principles underpinning the humanities as they relate to human rights (history, philosophy and sociology) and the ability to contribute to debate and use the analytical tools needed in the analysis of human rights issues;
- Expertise allowing the specific needs of developing countries to be met;
- Methodological rigour and a concern for a critical and documented approach to human rights issues;
- The ability to communicate orally and in writing, in a well-documented and well-argued manner, on issues relating to human rights.

### Programme structure

The programme is spread over one academic year and consists of 60 credits. It is designed to be balanced, with a total of 300 hours of teaching, including 120 hours of legal courses, 90 hours of humanities courses, 60 hours of optional courses and 30 hours of seminars leading to the final paper. In addition, optional tutorials are organised in order to facilitate the assimilation of the material.

### General access requirements

Art. 112. of the "Décret définissant le paysage de l'enseignement supérieur et l'organisation académique des études" :

§ 1. In accordance with the general requirements established by the academic authorities, students who have:

1. a master's degree;
2. an academic degree similar to the one mentioned in the preceding paragraph awarded by a higher education institution in the Flemish Community or the German-speaking Community, or by the Royal Military Academy, by virtue of a decision of the academic authorities and in accordance with any additional requirements they may establish;
3. a foreign academic degree recognised as equivalent to those mentioned in paragraphs 1 and 2 pursuant to this decree, a European directive, an international convention or other legislation, in accordance with the same requirements.

The additional admission requirements referred to in paragraph 2 are intended to ensure that the student has acquired the knowledge and skills required for the studies in question. When the additional admission requirements consist of one or more additional course units, these may not represent more than 60 additional credits for the student, taking into account all the credits that he or she may otherwise use for admission. These course units are part of the student's study programme.

§ 2. In accordance with the general requirements established by the academic authorities, a student who holds a title, diploma, degree or certificate of higher education, in the French Community or outside it, which does not grant him or her eligibility for admission to a specialised master's course by virtue of the preceding paragraph, may nevertheless be admitted by the jury of the course in question, in accordance with the additional requirements that it establishes, if the totality of the higher education that he or she has completed or the expertise that he or she has acquired is valued by the jury to be at least 240 credits.

§ 3. By way of derogation from these general requirements, the academic authorities may also admit to a specialised master's course holders of a title, diploma, degree or certificate awarded outside the French Community which, in that system of origin, grants direct eligibility for postgraduate studies, even if the studies sanctioned by these credentials are not organised into distinct degree courses or within a time period of at least five years.

### Specific access requirements

In accordance with the study and examination regulations for the advanced master's degree in human rights and the practices of its implementing bodies,

- entry is open to students who have excelled in their higher education studies or who have substantial personal or professional experience in the field of human rights, and are holders of one of the following qualifications (subject to approval by the board):
  - a 120-credit second-cycle degree in law;
  - a 120-credit second-cycle degree in a field related to the subject of the advanced master's degree, after a reasoned opinion from the board;
  - a 120-credit second-cycle degree, supplemented by the candidate's experience in the field of human rights gained through activities undertaken in either a private or a professional capacity, after a reasoned opinion from the board;
  - a degree similar to those mentioned above, issued by the Flemish Community of Belgium, the German Community of Belgium or the Royal Military Academy, subject to the same conditions;
  - a foreign degree recognised as equivalent to those mentioned above under the applicable legislation of the French Community, a European directive or an international convention, subject to the same conditions.

- The advanced master's degree is also open to students who, under the applicable legislation of the French-speaking Community, have access to studies leading to a second-cycle degree, and who have acquired competencies deemed by the board to have a value of at least 300 credits.

As a rule, the board considers that these competencies will not be recognised if the candidate does not already have a second-cycle degree.

The board may decide, where appropriate, to complement the student's programme of study with courses covering the fundamentals of international public law and/or covering the principles and sources of law. Each of these course units is worth 4 credits. The student is required to pass the associated additional examinations as a condition for obtaining the advanced master's degree in human rights.

## Teaching method

---

The effectiveness of the programme is ensured by the complementary nature of several teaching methods: lectures as well as exchanges of views which value professional experience and previous career paths, group work, individual work and mentoring.

The teaching methods are designed to make the most of the limited time available to adult students with professional and/or family lives.

## Evaluation

---

***The evaluation methods comply with the regulations concerning studies and exams (<https://uclouvain.be/fr/decouvrir/rgee.html>). More detailed explanation of the modalities specific to each learning unit are available on their description sheets under the heading "Learning outcomes evaluation method".***

Assessments are generally carried out by means of a written or oral exam. Examinations focus not only on knowledge of the subject matter, but also on a student's ability to apply it.

In addition, students must choose from one of three seminars, accompanied by the completion of a final paper. This provides an opportunity for an in-depth study of a subject related to human rights from a critical perspective. Just like the other courses in the programme, it is an educational means, in that it introduces students to independent and personal academic research. It takes the form of a written dissertation in keeping with university standards (search for sources, accuracy of references, bibliography, ethics), in which the student demonstrates his or her :

- ability to target a research question and explore it in depth;
- ability to find and use relevant sources, in particular doctrinal sources ('state of the art');
- ability to analyse, compare and summarise;
- critical thinking;
- rigour and clarity, both in the written presentation and the oral defence;
- compliance with the academic and ethical criteria which characterise university research.
