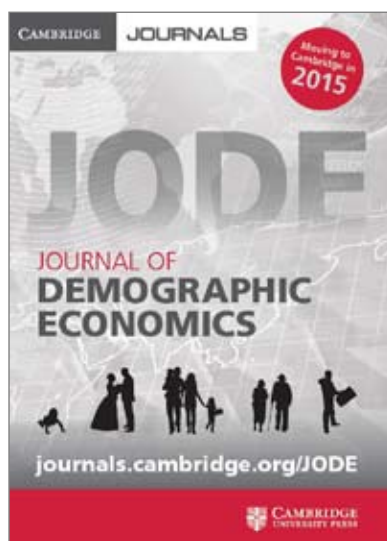

A New Start for Louvain Economic Review



Founded in 1929, *Recherches Economiques de Louvain - Louvain Economic Review* is a quarterly journal published by members of the Department of Economics of UCL. It publishes peer reviewed articles, theoretical and empirical, in the main fields of economics. In 2015, it will take a new beginning, switching to English-only content, and specializing into demographic economics, a field where Louvain is strong and could exploit its established networks. IRES and Cambridge University Press are proud to announce the birth of **JODE, the Journal of Demographic Economics**.

Its primary objective is to promote research in the field of study that lies at the intersection of economics and population studies. Papers will tackle questions raised by the challenges we are facing today: How should the developed world cope with population ageing? When will the very poorest countries begin to see a demographic transition? Should global migration be encouraged? What are the implications of the fast family transformations we presently observe? Answering these questions requires understanding economic incentives. It follows that research with a strong methodological discipline that exploits the complementarities between theory and empirics, and between demography and economics, will be an important focus for *JODE*.

New Members and Visitors



In September 2013, **Ilse Ruyssen** joined IRES for a one-year postdoc under the ARC convention on "Geographical mobility of workers and firms". Ilse obtained her PhD from Ghent University. In her dissertation, she empirically investigated the determinants of international migration and migrants' location choice. The focus was on identifying the driving forces of migration to the OECD and between African countries, with specific attention to dynamic processes and spatial dependence. She also analyzed to what extent immigrants' choice of residence within Belgium is driven

by networks versus the genuine appeal of municipalities. Another part of her research involves the role of European immigration policies in shaping migration streams from African countries. At IRES, she is exploiting new micro-data on desired migration. She compares desired migration with actual migratory movements and study how removing legal migration barriers could affect migration flows. She is also involved in another research project on bilateral migration and international conflicts.

Maurice Schiff visited IRES between September 16 and 20, and between October 24 and 29, 2013. Maurice got his PhD from the University of Chicago. He spent two years as Professor and Research Director of the Faculty of Economics and Business of the University of Concepcion in Chile. He then served as a Lead Economist in the World Bank International Trade Unit (Development Research Group) and directed the Research Program on International Migration until 2012. He is presently International Consultant in the Development Economics Research Group at the World Bank. His fields of expertise are international trade, agriculture, regional integration, trade and technology diffusion, and international migration. He published more than ten books and many articles in journals such as Journal of International Economics, European Economic Review, Journal of Development Economics, World Bank Economic Review, American Journal of Agricultural Economics, Canadian Journal of Economics, etc. During his stay at IRES, Maurice collaborated with Frédéric Docquier, Fabio Mariani and Ilse Ruysen on several issues such as (i) the relationship between bilateral migration, trade and international conflicts, (ii) the labor market integration of immigrants in the OECD countries, and (iii) political economy models of immigration policies. Maurice's stay at IRES was funded by the ARC convention on "Geographical mobility of workers and firms".

The Belgian Social Model: which future? The Labor Market as Component of the Social Model.

"The Belgian Welfare State is questioned". How many times haven't we heard this warning! The banality of the statement does not remove anything from the reality of the challenge. How to take it up? Three major questions were at the heart of the debates of the 20th Belgian economists congress that took place on 21st November in Charleroi. These debates have been prepared by commissions who gather scientific contributions from various Belgian and foreign institutions and universities.

The first question, the best-known one, is about the sustainability of the Belgian social model. The second question is about the performance of the system. The third question is about risks prevention. To which extent do our training and employment systems reduce the long-term unemployment and low-income risks?

The commission chaired by **Bruno Van der Linden** (IRES, UCLouvain) dealt with employment in Wallonia and Brussels. It starts from the observation that Brussels and Wallonia have had a high unemployment rate for almost 40 years. This commission dealt with the following questions. Beyond simplistic statements, how can we assess the German experience and what can be learnt from it about social dialogue? Can the Belgian collective dialogue find innovative compromises? Between the status quo of the current automatic wage indexation and those in favour of its abrogation, isn't there a median way of reforming? Are our wage-setting mechanisms disconnected from the persistent unemployment reality and from the consequences of an ageing workforce in a monetary union? What is the coherence of our various minimum wages? And what implications do they have? Which first lessons can be learnt from the recent unemployment-insurance reform? Does the future of active labor market policies lie in individual counselling and job-search assistance?

• **“International labor mobility and inequality across nations” – 23-24 January, 2014**

An International Conference on “International labor mobility and inequality across nations” will be held in Clermont-Ferrand on January 23-24, 2013. This conference is jointly organized by FERDI, IRES (UCLouvain) and CERDI (UdA). It is funded by the ARC research project on “Geographical Mobility of Workers and Firms”.

The conference is devoted to investigating the effects of international migration on the geographic distribution of human capital and its implications for the world economy. Questions to be addressed are: How large are migration flows (by education and by gender)? How does labor mobility affect inequality across nations? What are the determinants of migration flows/stocks? Are policy barriers quantitatively important? How would the world economy respond to a (selective or non-selective) liberalization of labor mobility? The conference will include 24 presentations organized in 8 thematic sessions and presentations by invited speakers: Michel Beine (University of Luxembourg), Paul Collier (University of Oxford), Jesús Fernández-Huertas Moraga (FEDEA-IAE-CSIC), Maëlan Legoff (CEPII), Andrew Mountford (Royal Holloway London), Çağlar Özden (World Bank), Chris Parsons (University of Oxford), Hillel Rapoport (Bar Ilan University), Sara Salomone (IRES, UCLouvain).
